Course outline

The Chronic Disease Care Planning Course aims to provide students with the skills and knowledge necessary to determine the support needed for chronic disease management, including person-centric care, engaging the client, identifying and managing risk factors, and contributing to a multi-disciplinary service approach within the care planning model.

Course content

The face to face workshop involves lecture and practical workshop activities around the application of chronic disease care planning in primary health care

Course structure

To achieve competency students must demonstrate successful completion of:

- Case studies, scenarios and oral questioning in the classroom
- Care planning Students will be deemed competent on successful completion of all activities within the workshop, including the completion of 3 care plans.

Entry requirements

Entrants to the Chronic Disease Care Planning course must provide evidence of a relevant professional role.

- General Practice Registrars
